Summary of AIC International's Training Resources

Introduction

Over the years, thanks to the hard work of the international training committees, we have built up a rich library of resources.

But when a training need arises in our group or association, how often do we think to go to the AIC website and consult these resources? And do we know what resources this online library contains and how to find them?

Besides, the pandemic has changed the context in which we support our brothers and sisters living in poverty, and our training needs may have evolved accordingly. It is therefore of interest to know whether the AIC online library contains training materials that may be useful to us.

These reasons led to the decision to produce this document, which presents a little summary of AIC International's existing training resources. It is intended to serve as valuable tool for the training of all AIC groups.

Creation process of our virtual AIC library

When we reach the end of a series of training reflections, we publish it on the AIC website (<https://www.aic-international.org/en/publications/training-booklets/>).

These training reflections are organized chronologically, starting with the most recent. Initially, there were two categories of training documents: spiritual and technical ones. Over the last few years, this distinction has been progressively removed and most training documents now seek to address both dimensions.

In the following summary, we have reorganized the training reflections by theme (and by chronological order within each theme). Some of them were written some time ago, but their content remains relevant and interesting.

The aim is to help you easily identify whether there is anything you have missed or would like to go back to in order to strengthen your skills and knowledge in a particular area.
